Travel Insurance is Recommended for your Trip

A trip protection plan is a great way to safeguard your trip.

- Trip Cancellation/Interruption coverage can insure your nonrefundable trip costs in the event that you need to cancel or interrupt your trip for a variety of Unforeseen covered reasons listed in the policy.
- Upgrading to Cancel for Any Reason (if eligible) can protect up to 75% of your trip costs if you need to cancel for any other reason.
- Trip Delay coverage can help with costs related to delayed travels, including quarantine.
- Travel Medical coverage can help you with medical expenses that arise during your trip.

Coverage Type	Primary

- Comprehensive coverage for trip cancellation, trip interruption, emergency medical and post-departure travel coverage.
- Pre-Existing medical condition exclusion waiver included when policy is purchased within 21 days of the Initial Trip Deposit Date and prior to Final Pre-Departure Trip Payment
- Up to \$250,000 in PRIMARY emergency medical coverage.
- Cancel for Any Reason available (in most states).
- **Note:** Cancellation of an event on your trip, by the travel supplier, is not listed as a covered reason for a Trip Cancellation or Trip Interruption claim for the entire trip (flights, other prepaid accommodations). The Cancel for Any Reason Upgrade can be a helpful coverage option for these circumstances.

Cancel for Any Reason - 75% of Trip Cost (Optional Upgrade, not available in NY and WA)

Provides reimbursement for the percentage of the prepaid, non-refundable, forfeited payments you paid for your trip, if you cancel your trip for any reason not otherwise covered by this policy. Upgrade must be purchased with initial policy and within 21 days of the initial trip payment date of any kind; trip must be canceled two (2) days or more before Your Scheduled Departure Date. *See full policy for more details.

Pre-existing Medical Condition Exclusion Waiver

Exclusion is waived if coverage is purchased within 21 days of the Initial Trip Deposit Date and prior to Final Pre-Departure Trip Payment, and you are medically able to travel on the policy effective date.

10 Day Review Period

If you are not satisfied within 10 days of purchasing this plan, your premium cost can be refunded if you have not departed on your trip or filed a claim (not available in all 50 states).

Trip Cancellation and Trip Interruption due to (may differ by state of residence)

- Sickness, Injury or Death of You, a Family Member or Traveling Companion
- Inclement Weather, Natural Disaster that prevents you from reaching your destination. **If storm was not forecasted at time of purchase of the policy.*
- Terrorist Incident that occurs in Your departure city or in a city listed on Your Trip itinerary during Your Trip.
- Hijacked, Quarantined, required to serve on a jury, or subpoenaed
- Complications of Pregnancy of You, a Family Member or Traveling Companion **see Certificate of Insurance for definition*
- Termination, Layoff or Transfer of Employment
- Company made unsuitable for business by fire, flood, burglary, vandalism or other Natural Disaster
- Revoked military leave Being called to emergency duty to provide aid or relief in the event of a Natural Disaster (this does not include war)
- Your accommodations at Your destination made inaccessible due to fire, flood, volcano, earthquake, hurricane or other Natural Disaster
- Mandatory Evacuation due to hurricane or other Natural Disaster
- Bankruptcy or Default of a Travel Supplier
- Your Home made Uninhabitable by Natural Disaster; or burglary
- Mechanical breakdown of Your Common Carrier's aircraft Strike
- Your arrival on the Trip being delayed due to a Hazard that causes You to lose fifty percent (50%) or more of the scheduled Trip duration
